Name of Standard	PS3.3, PS3.6, PS3.15
Rationale for Correction:	<p>In Point of Care Ultrasound, the supervising physician (a.k.a., attending physician) holds ultimate responsibility for the patient encounter and the associated POCUS reports, particularly when POCUS learners or medical trainees, are involved. This responsibility includes ensuring that the care provided is appropriate and that the POCUS reports are accurate.</p> <p>DICOM does not include an attribute for supervising or attending physician, however, it does include Physician(s) of Record (0008,1048), who is responsible for primary care of patient during the study.</p> <p>This CP is to add Attending Physician to the Visit Admission Module.</p> <p>Note: Adding Attending Physician to the Visit Admission Module will also add it to the Modality Worklist Information Model.</p>
